Provisional Membership Process

1.Eligibility

a. Applicants must be at least 18 years of age unless they are included in a family application.b. Applicants must not have been a previous Full or Provisional Member of FSMBC unless specifically authorised by the Management Committee.

c. Applicants must not have had a previous application for Provisional Membership rejected, withdrawn or cancelled.

- 2. Completed **application forms** should be sent to the New Member Administrator. The Management Committee reserve the right to accept or reject any application. Should an application be rejected, a full refund will be given.
- **3. Provisional Membership** will normally be for a period of up to 3 months. This period may be amended at the discretion of the Management Committee.
- 4. With application acceptance and payment of the £25 fee per completed application form, Provisional Members will be issued with a key-fob for access to the Club, be given access to the Members Section of the Club Website and receive details of how to apply for Full Membership.

5. Provisional Members:

a. will have use of Clubhouse facilities, may attend social events (charges may be payable) and can take part in Club races.

b. may not vote at General Meetings or take part in the management of the Club.

- **6. The Management Committee** reserve the right to terminate Provisional Membership at any time; no appeal will be permitted.
- **7.** Prior to submitting an application for Full Membership, adult candidates will be required to: a. shadow a bar Workscheme duty which will be annotated by the Club member concerned.

b. shadow a galley Workscheme which will be annotated by the Club member concerned.

c. obtain two Club sponsors, one of whom must be a member of the Management Committee. together with their sponsors, attend an informal social / information meeting organised by the New Member Administrator.

e. familiarise themselves with current Club Rules and Bye-Laws and agree to abide by them. These can be viewed in the Members Section of the Club Web Site.

- 8. Applications for Full Membership will be assessed by the Management Committee. If the application is rejected, no reason will be given and the Provisional Membership will be cancelled immediately.
- **9. Successful applications**. The annual membership period for Full Membership is from 1st January to 31st December. If the application is successful, Full Membership will be granted on receipt of the joining fee (less the £25 fee) together with the annual membership fee adjusted on a pro-rata basis depending on the number of months remaining in the membership year. These charges must be paid within 28 days of the offer of Full Membership.
